Assoc. Prof. Nikolay Georgiev submitted 29 publications in journals that are referenced in the databases "Scopus" or "Web of Science" in the competition for the academic position of "professor", of which 1 article is published in Bulgarian scientific journal.

In the competition, Assoc. Prof. Nikolay Georgiev is the only candidate and presents himself with the following indicators:

Indicator 1 – 50 pts.

Indicator 3 or 4 – 177 pts. (required minimum 100 points)

Indicators 5 to 11 – 226 pts. (required minimum 200 points)

Indicators 12 to 14 – 350 pts. (required minimum 100 points)

Indicators 15 and 16 - 40 pts.

Indicators 17 to 21 – 30 pts.

Indicators 23 to 26 - 80 pts.

Total number: 953 (exceeds required minimum).

Associate Professor Nikolay Georgiev participate in the competition with 29 publications, referenced and indexed in international databases. Publications 1 to 10 are presented as the equivalent of a thesis (indicator 4). The remaining publications meet the criteria of indicators 5 to 11. In total, the publications can be arranged as follows: 12 pcs. – Q1, 11 pcs. – Q2, 5 pcs. – Q3, 1 pc. – Q4 (according to SCIMAGO in the year of publication of the article in the respective journal). In total, the scientific publications presented in the competition have been cited by other authors 429 times (according to SCOPUS as of the date of this review).

Associate Professor Georgiev presented a list of 47 diploma students supervised by him, as well as data of one doctoral student. A list of 10 lecture courses conducted by him is presented. Data on published teaching booklet and registered patent are also presented (indicators 23 to 26.

The evaluation of the relevance of the research must be substantiated.

Assoc. Prof. Georgiev's research activity is focused on the synthesis of functionalized organic compounds possessing fluorescent properties and possible applications as molecular sensors and elements of molecular electronics. The relevance of the developments is demonstrated by the practical orientation of the results to biology and medicine. Associate Professor Georgiev has successfully arranged his main scientific results in the following 3 groups: 1. Synthesis and research of new multichromophore systems for energy transfer at the molecular level; 2. Synthesis and research of new fluorescent molecular sensors; 3. Synthesis and research of new molecular logic devices and facilities. In his research, Assoc. Prof. Georgiev demonstrate skills in the design and implementation of the synthesis of new organic structures with previously considered properties and possible applications.

The relevance of the obtained results is evident from the numerous citations of Prof. Georgiev's articles in the international scientific literature.

The goals that Prof. Georgiev sets for himself are scientific in nature, aimed at specific applications. They are in the thematic area of the competition and are realistically placed. Results have been achieved, both in the field of synthesis of new multifunctional organic compounds, but also in materials science in the search for structures with certain properties aimed at applications.

Research methods correspond to the set goals. Associate Professor Georgiev applies modern approaches for organic synthesis and physicochemical characterization of the properties of the

obtained compounds (e.g. NMR and IR spectroscopy, etc.). The fluorescence properties of the synthesized compounds and their dependence on the structure are especially thoroughly studied. Dynamic phenomena with charge transfer are studied, which are the basis of designing organic structures with pre-defined properties.

The contributions to the scientific activity of Prof. Georgiev, within the framework of the materials presented in the competition, can be formulated as follows:

- Multifunctional compounds containing 1,8-naphthalimide structural fragments have been synthesized, by means of which energy transfer is modulated and the properties of molecular rotors and switches are aimed at;
- Organic compounds possessing the properties of fluorescent sensors (to detect metal ions or organic pollutants harmful to the environment) have been synthesized;
- From the idea of synthesis of organic devices and switches, Associate Professor Georgiev logically turns to studying the possibilities of applying such compounds as molecular logic devices.

The generally interrelated lines of research listed are of substantial applied interest.

Associate Professor Georgiev is a corresponding author in three of the publications presented in the competition. Obviously, his participation in the presented research and the achieved results is equal to that of the other co-authors. It should be noted that to a significant extent the scientific topic was developed by Prof. Vladimir Bozhinov, under whose leadership the candidate began his scientific career and developed further this scientific field.

In appendix 6b (file "pril\_6b\_Zitati"), there is probably an error - 35 articles are presented in the column "scientific work where the candidate's publication is cited", where the name of the journal is missing. In addition, in the column "No. of the publication (from the list of the applicant's publications) that is cited" is noted article No. 8, which was actually cited only 3 times by foreign authors (according to SCOPUS).
